**'TERMS AND CONDITIONS'**

The following terms and conditions apply to the 'Greater Springfield eNews - \$1000 Cash Giveaway' competition.

**1. Definitions**

- 1.1 The term 'Promotion Period' means the period commencing Thursday 28th January 2010 until 5.30pm Sunday 28 March 2010.
- 1.2 The term 'Subscriber' means any person who applies to receive the Greater Springfield eNews. Each Subscriber is required to provide first and last name, mobile phone, email address, postcode, age, and agree to the Terms and Conditions of the promotion. An email address cannot be entered as a new subscriber more than once.
- 1.3 The 'Promoter' is SLC. SLC means Springfield Land Corporation Pty Ltd ACN 055 714 531., Level 10, Springfield Tower, 145 Sinnathamby Boulevard, Springfield central QLD 4300
- 1.4 The 'Prize' refers to the prize(s) described in clause 3 to be awarded by the Promoter in conjunction with the Promotion.
- 1.4 The 'Prize Winner' means the Subscriber who wins the Prize in accordance with clause 4.1.
- 1.5 The 'Promotion' refers to Greater Springfield eNews - \$1000 Cash Giveaway'.
- 1.6 The 'Terms and Conditions' means these terms and conditions.

**2. Details of the Promotion**

- 2.1 The Promoter is conducting the Promotion.
- 2.2 Entry to the Promotion is free.
- 2.3 Information on how to enter and prizes form part of these terms and conditions. By subscribing to the Greater Springfield ENews on the Greater Springfield website you accept these terms and conditions.
- 2.4 The Promotion is open to all Australian residents who are 18-years and over.
- 2.5 To enter the promotion, the entrant must subscribe to the Greater Springfield eNews by logging onto [www.greaterspringfield.com.au](http://www.greaterspringfield.com.au). The entrant cannot register using the same email address more than once.
- 2.6 All existing subscribers are automatically entered into the draw for the Prize.
- 2.7 The Promotion starts on 28 January 2010. The closing date and drawing date will be 28 January 2010.
- 2.8 The drawing date will be after 5.30pm on 28 March 2010.

**3. The Prize**

- 3.1 The Prize refers to \$1000 AUD cash.
- 3.2 The Prize is non transferrable.
- 3.3 The Prize will be delivered by cheque to the address of the prize winner within fourteen (14) days after the Prize Winner's name is drawn in accordance with clause 4.1.

**4. Prize Draw**

- 4.1 The Prize will be awarded by a random method which is based purely on chance. The Prize Winner need not be present at the draw. The Promoter will draw the name of a Subscriber at random from the Greater Springfield eNews subscriber database.
- 4.2 If not present at the draw, the Promoter will contact the Prize Winner by phone and/or email and arrange delivery of the Prize in accordance with clause 3.3 above. If the Prize Winner does not bank the cheque within fourteen (14) days after the Promoter delivers the cheque to the winner in accordance with clause 3.3 above, an alternate winner will be chosen in the same manner as specified in clause 4.1 above.
